

JEOPARDY

Objective

To provide a competitive environment for the reinforcement of material covered in earlier training sessions, based on the television game show "Jeopardy".

Procedure

Develop a set of test questions, organized into categories covering the material taught and with an increasing scale of difficulty. Some general knowledge categories can be added. Organise 3 teams of one or more people and provide "noise makers". Allow a team to select a category and value. The first team to indicate must provide an answer to the question. If they are incorrect, the other teams get a chance. Points are added or deducted to team scores for right or wrong answers. The winner is the team with the highest score at the end of a set time period or the first team to reach a specified number of points. The following example questions are based on Toastmasters and District 70.
